PAYMENT POLICY

- Fee payment is either **MONTHLY** or on a **DROP-IN** basis.
- Monthly tuition is payable **IN ADVANCE** on the **FIRST 10 DAYS** of each month. If enrolling after the first week of the month, the tuition fee will be calculated according to the remaining classes of the concerned month.
- Monthly tuition is based on the predetermined **dance or fitness program** that the student is enrolled in – type of class and number of classes per week –.
- No refunds or discounts will be issued for any missed class or early withdrawal during the month.
- No credit or compensation will be offered toward the next monthly tuition for classes missed in a previous month.
- Missed classes may be made up within the 2-month period following the missed class, by attending any **additional class out of the dance or fitness program the student is enrolled in**.
- **Make-up classes** are not guaranteed but **offered as a courtesy**, if space is available.
- The monthly fee remains the same regardless of the varied number of weeks in a month. There is no additional charge for five-week months and holidays and closures will be duly considered in the respective monthly tuition.
- If a class is cancelled due to weather or other unforeseen reasons, make-up classes will be offered before the year end.
